## THIRD WITNESS STATEMENT OF KHYLE RODGERS

I, KHYLE RODGERS, of

, say as follows:

- I refer to my first witness statement dated 2 October 2018 ("First Witness Statement") and my second witness statement dated 18 October 2018 ("Second Witness Statement"). Unless otherwise stated or the context otherwise requires, any abbreviations shall bear the same meaning as in my First Witness Statement and Second Witness Statement.
- 2. I make this statement in response to the statements of China Technology's witnesses. Any allegations or matters raised in those statements (or any other statements) which are inconsistent with my First Witness Statement and Second Witness Statement are denied. If I do not address any allegations or matters raised in other witness statements, it should not be construed as an admission on my part.
- 3. Unless otherwise stated, the facts stated herein are within my personal knowledge and are true. Where the facts and matters stated herein are not within my own knowledge, they are based on the stated sources and are true to the best of my knowledge.
- 4. The witnesses from China Technology allege that they witnessed the threaded ends of rebars being cut in specific locations on the site and on specific dates. It is therefore relevant to identify the final dates when reinforcement would have been installed in each area of the EWL Slab and NSL Slab. I was the superintendent of the HUH section of the Project which included the EWL Slab and NSL Slab, and can comment on this matter.
- I note that the last concrete pours for the following areas of the EWL Slab and NSL Slab were completed on the following dates:
  - (a) EWL Slab Area A 24 July 2015 (Bay 6)<sup>1</sup>;

- (b) EWL Slab Area HKC 16 August 2016 (Bay 3)<sup>2</sup>;
- (c) NSL Slab Area A 21 May 2016 (Bay A NSL 5)<sup>3</sup>;
- (d) NSL Slab Area B 18 May 2016  $(B NSL B2)^4$ ; and
- (e) NSL Slab Area C 26 April 2016 (C1 NSL C1-0)<sup>5</sup>.
- 6. My knowledge of the dates of all concrete pours for EWL Slab and NSL Slab is taken from the concrete test results for the EWL Slab and NSL Slab.<sup>6</sup> In particular, the dates noted above for the concrete pours reflects the "sample date" in the test results. These test results were prepared by an independent laboratory. A copy of these concrete pour test results is produced and marked Exhibit "KR-1".
