COMMISSION OF INQUIRY INTO THE CONSTRUCTION WORKS AT AND NEAR THE HUNG HOM STATION EXTENSION UNDER THE SHATIN TO CENTRAL LINK PROJECT

SUPPLEMENTAL WITNESS STATEMENT OF TANG SIU HANG, TONY FOR MTR CORPORATION LIMITED

I, TANG SIU HANG, TONY, of MTR Corporation Limited, MTR Headquarters Building, Telford Plaza, 33 Wai Yip Street, Kowloon Bay, Hong Kong, WILL SAY AS FOLLOWS

- 1. I am the same Tang Siu Hang, Tony who provided a witness statement dated 2 May 2019 (the "First Witness Statement) [BB1/121-139]. I am duly authorised by MTRCL to make this supplemental witness statement on its behalf to clarify a few matters stated in the First Witness Statement.
- 2. At paragraphs 11, 29, 33, 49 and 52 of the First Witness Statement [BB1/123, 128, 129, 133, 134], I explained that I was not involved in the rebar fixing inspections. I would like to clarify that I was not involved in rebar fixing inspections in NAT (including the 3 Stitch Joints and the Shunt Neck Joint), but I was involved in some of the rebar fixing inspections in NFA.
- At paragraph 36 of the First Witness Statement [BB1/129-130], I stated that with regard to the photos that I took during the rebar fixing and concreting works of the track slabs at the 3 Stitch Joints, the now known defective coupler connections at the 3 Stitch Joints were not readily apparent to the naked eye during my daily surveillance.

4. I have now had an opportunity to study the photos taken at the 3 Stitch Joints during the rebar fixing and concreting works of the track slabs as retrieved from the MTRCL's server. I wish to clarify that having now carried out a detailed and close examination of these photos and upon reflection, it is possible that some of these photos may show defective coupler connections.

- 5. I make this clarification whilst reiterating that my daily surveillance focused on: (i) general works being constructed/installed; (ii) general progress of site works; (iii) general site management; and, (iv) safety. It was not my responsibility to and I did not conduct any 'man-marking' or continuous supervision over the rebar fixers when they were conducting their coupler connection works, which was the responsibility of Leighton.
- 6. Given that the focus of my daily surveillance did not include a detailed inspection of the quality of the coupler connections, the now known defective coupler connections at the 3 Stitch Joints were not obvious to me during my daily surveillance at the time and I did not see any.

7. At paragraphs 37 to 45 of the First Witness Statement, I set out the discovery of water seepage at the Stitch Joints in 2019 and the rectification works that have been carried out since. In those paragraphs, I referred to the "3 Stitch Joints". I would like to clarify that water seepage in 2019 was only discovered at the 2 NSL Stitch Joints (and not the EWL Stitch Joint) and rectification works were only carried out at the 2 NSL Stitch Joints. Therefore, references to the "3 Stitch Joints" in those paragraphs should read as references to the "2 NSL Stitch Joints".
